## Vendor Rules & Regulations

### **Connecticut Bike Blessing Sponsored by New London Motorcycle Club and Ocean Beach Park**

**Space:** The space contracted for is to be used solely by the exhibitor whose name appears on the contract and it is agreed the exhibitor will not sublet or assign any portion of the same without the written consent of management. Improvements: Any additions or improvements to space other than the standard equipment shall be subject to the approval of New London Motorcycle Club, Boston Culinary Group Inc/Ocean Beach Park, and the City of New London, and at the exhibitor's expense. All decorations must be flameproof. No open flames permitted. **Merchandise Exhibited:** No exhibitor shall exhibit or permit to be exhibited any merchandise other than motorcycle products, accessories or services. New London Motorcycle Club, Boston Culinary Group Inc/Ocean Beach Park, and the City of New London will prohibit the installation of any and all exhibits not approved by them. **Liability:** The exhibitor is entirely responsible for the space allotted and agrees to reimburse New London Motorcycle Club, Boston Culinary Group Inc/Ocean Beach Park, and the City of New London for any damage to parking lot/pavement or equipment that has been made in the space under contract. **Insurance:** The exhibitor agrees to save New London Motorcycle Club, Boston Culinary Group Inc/Ocean Beach Park, and the City of New London - its officers or agents and/or the venue harmless and free from all damages or other liability occasioned within the wrongdoing of the exhibitor, employees or any officers, agents, or representatives, and said exhibitor will at own cost and expense defend and protect Boston Culinary Group Inc/Ocean Beach Park, City of New London or New London Motorcycle Club and/or the venue against any and all such claims and demands. New London Motorcycle Club, Boston Culinary Group Inc/Ocean Beach Park, and the City of New London assumes no responsibility whatsoever for any property placed in the venue and it is hereby understood and agreed that New London Motorcycle Club, Boston Culinary Group Inc/Ocean Beach Park, and the City of New London is hereby expressly released and discharged from any and all liabilities from any loss, injury, or damage to persons or property that may be sustained while on the premises or while in transit to the premises. The management, while taking all precaution against loss, will not guarantee against it. Exhibitors wishing to insure their goods must do so at their own expense. **Merchandise Removal:** No merchandise will be permitted to pass out of the venue without a Standard Removal Order signed by the floor Manager. No exhibit or part of exhibit may be removed until after the closing hour of the show. Any infraction of this rule may cancel participation in future New London Motorcycle Club, Boston Culinary Group Inc/Ocean Beach Park, and the City of New London shows. **Use of Aisles, etc.:** The aisles and passageways remain strictly under the control of management. This does not qualify or limit the free responsibility of the exhibitors to save New London Motorcycle Club, Boston Culinary Group Inc/Ocean Beach Park, and the City of New London, its officers or agents and/or the venue harmless and free from all damage or other liability, as set out in a prior section of this instrument. All exhibits must remain within the confines of the exhibitor's space and no exhibitor will be permitted to erect signs or display products in such a manner as to obstruct the view, occasion injury or disadvantageously affect the display of other exhibitors. **Restrictions:** Management reserves the right to restrict exhibits that may have been falsely entered, or may be deemed unsuitable. This reservation applies to noise, persons, things, conduct, printed matter or anything that might be objectionable to the show as a whole; it also applies to exhibits or advertising in all areas of the venue. The management must approve all signs. **Rights of Show Management in Event Exhibition is not Held:** In the event the show is not held or is prematurely closed as a result of any emergency arising previous to the scheduled date of the show or during the show, as for instance, destruction of or damage to the venue by fire, strikes, electrical failure, war, government regulation, or acts of God, etc., it is expressly understood and agreed that management shall retain the exhibitor's entire rental fee. No refunds. **Rights of Show Management:** In the event that any exhibit of the exhibitor would interfere with building regulations, fire ordinance, the exhibit of other exhibitors, or show regulations, New London Motorcycle Club, Boston Culinary Group Inc/Ocean Beach Park, and the City of New London reserves the right to relocate the space. **Booth Manning:** New London Motorcycle Club, Boston Culinary Group Inc/Ocean Beach Park, and the City of New London expect booths to be manned at all times during the show. The exhibitor must have an attendant in charge of this exhibit during the hours of the show. **Dogs:** No dogs allowed.
